If an estate plan is like building a house, then an estate design is like the blueprint. A well-constructed estate design will help you in the following ways:

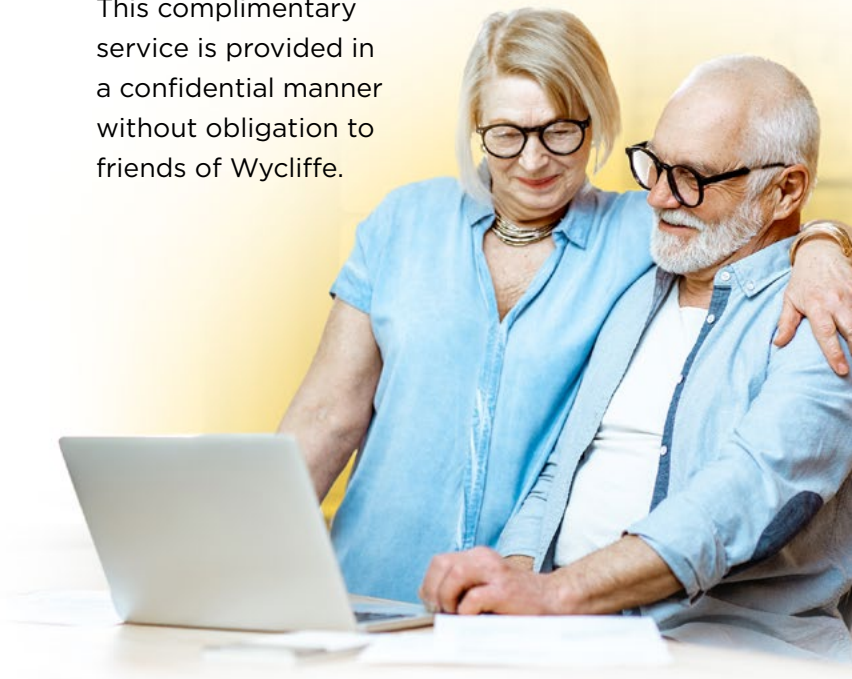

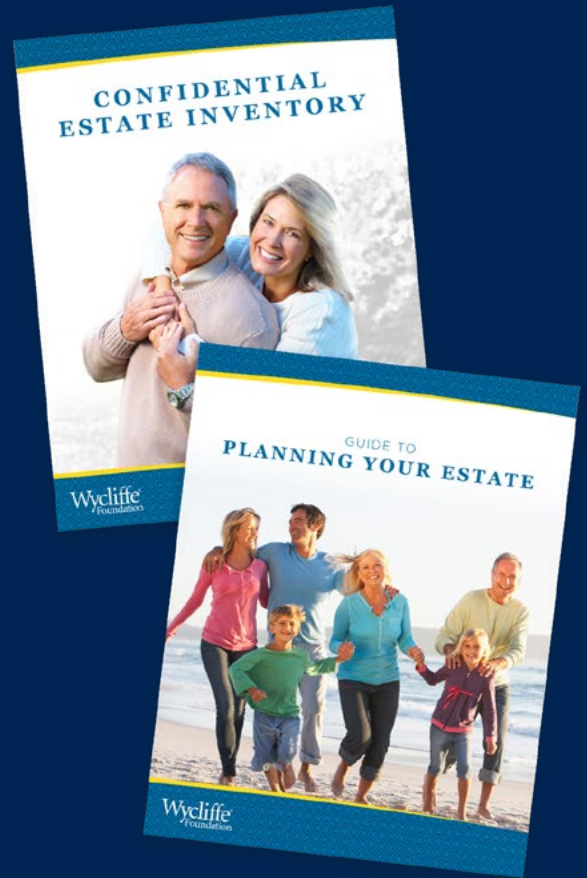
